Bill No. and sponsor: H.R. 4486 (Mr. John Culberson of Texas).

Proponent name,³ location: Solvay Chemicals Inc., Alpharetta, GA.

Other bills on product (110th Congress only): H.R. 4445 (Mr. Ron Lewis of Kentucky).

Nature of bill: Temporary duty suspension through December 31, 2011.

Retroactive effect: None.

Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Caprolactone-diethylene glycol copolymer (CAS No. 75035-33-5) (provided for in subheading 3907.99.01).

Check one: Same as that in bill as introduced.
 Different from that in bill as introduced (see Technical comments section).

Product information, including uses/applications and source(s) of imports:

The subject product is a high performance caprolactone diol that is derived by polymerizing epsilon-caprolactone monomer with diethylene glycol as an initiator. This colorless to pale yellow liquid polymer is known for its superior chemical, abrasion, hydrolytic, and UV resistance compared to other polyester polyols. The product is primarily used to produce solvent-based coatings. It is imported from Japan and the United Kingdom.

7 amended by inserting in numerical sequence the following
8 new heading:
