

 - a. Begin typing the name of the non-party participant into the “Search Participants” field.
 - b. A list of potential matches will appear as the user is typing. If there are multiple entries matching a the non-party, hover the cursor over each entry to view the complete address information and then select the entity with the correct address by clicking on it.
 - c. Once a non-party has been selected, select the only option from the dropdown “Participant Type” list prior to clicking on the “Add” button.


