

NOTICE OF INITIAL DETERMINATION ON VIOLATION OF SECTION 337

(August 23, 2016)

On this date, I have issued an initial determination on violation of section 337 in this investigation pursuant to Commission Rule 210.42(a)(1)(i). For the reasons discussed therein, it is my Final Initial Determination that there is no violation of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and/or the sale within the United States after importation of certain activity tracking devices, systems, and components thereof because no party has been shown to have misappropriated any trade secret.<sup>1</sup> A public version of the initial determination shall issue within 30 days, or in the time necessary to identify and redact the confidential business information therein, pursuant to Commission Rule 210.5(f).
