

Harmonized Tariff Schedule of the United States (2015)

Annotated for Statistical Reporting Purposes

Because no printed supplement was issued during 2014, this change record sets forth all changes to the HTSA which have become effective since January 1, 2014, *other than* previously proclaimed reductions in staged rates of duty which take effect on January 1, 2015, and nonsubstantive adjustments to the format of any page. As such, this enumeration includes changes made in revision 1 to the 2014 basic edition, changes effective on January 1, 2015, and changes effective on January 29, 2015.

The provisions set forth in Presidential Proclamation 9223, which became effective January 29, 2015, affected chapters 29, 30, 37, and 85 and are enumerated in this change record. All files comprising the official HTSA are being reposted for January 29, 2015.
