**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW INITIAL
DETERMINATIONS FINDING THIRTEEN RESPONDENTS IN DEFAULT**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 19) of the presiding administrative law judge (“ALJ”) finding respondents Ourway Image Tech. Co., Ltd., Ourway Image Co., Ltd., and Zhuhai Aowei Electronics Co., Ltd. (“the Ourway respondents”), all of Zhuhai, China; Acecom, Inc. – San Antonio d/b/a InkSell.com (“InkSell.com”) of San Antonio, Texas; Bluedog Distribution Inc. (“Bluedog”) of Hollywood, Florida; i8 International, Inc. d/b/a Ink4Work.com (“Ink4Work.com”) of City of Industry, California; Ink Technologies Printer Supplies, LLC (“Ink Technologies”) of Dayton, Ohio; Linkyo Corp. d/b/a SuperMediaStore.com (“SuperMediaStore.com”) of La Puente, California; CLT Computers, Inc. d/b/a Multiwave and MWave (“CLT Computers”) of Walnut, California; Imaging Supplies Investors, LLC d/b/a SuppliesOutlet.com, SuppliesWholesalers.com, and OnlineTechStores.com (“Imaging Supplies”) of Reno, Nevada; Online Tech Stores, LLC d/b/a SuppliesOutlet.com, SuppliesWholesalers.com, and OnlineTechStores.com (“Online Tech Stores”) of Grand Rapids, Michigan; Fairland, LLC d/b/a ProPrint (“ProPrint”) of Anaheim Hills, California; and 9010-8077 Quebec Inc. d/b/a Zeetoner (“Zeetoner”) of Quebec, Canada in default (collectively, “the thirteen respondents”).

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on March 29, 2018, based on a complaint filed on behalf of Canon U.S.A. Inc. of Melville, New York, Canon Inc. of Tokyo, Japan, and Canon Virginia, Inc. of Newport News, Virginia. 83 FR 13516-17. The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, by reason of infringement of certain claims of U.S. Patent Nos. 9,746,826; 9,836,026; 9,841,727; 9,841,728; 9,841,729; 9,857,764; 9,857,765; 9,869,960; and 9,874,846. The Commission's notice of investigation named numerous respondents, including the thirteen respondents and Print After Print, Inc. d/b/a OutOfToner.com ("Print After Print") of Phoenix, Arizona. The Office of Unfair Import Investigations is also a party to the investigation. The complaint and notice of investigation were served on these fourteen respondents. *See* Order No. 19 at 2. These respondents failed to respond to the complaint and notice of investigation.

On June 7, 2018, complainants filed a motion, pursuant to 19 CFR 210.16, for the following: (1) an order directing the fourteen respondents to show cause why they should not be found in default for failure to respond to the complaint and notice of investigation as required by 19 CFR 210.13; and (2) the issuance of an ID finding respondents in default upon their failure to show cause. OUII and the actively participating respondents in the investigation did not oppose the motion and no responses to the motion were filed by the fourteen respondents.

On June 19, 2018, the ALJ issued Order No. 16 which required the fourteen respondents to show cause no later than June 29, 2018, as to why they should not be held in default and have judgment rendered against them pursuant to 19 CFR 210.16. Print After Print responded to Order No. 16, but no responses were received from the other thirteen respondents.

The ALJ issued the subject ID (Order No. 19) on July 11, 2018, finding the thirteen non-responding respondents in default, pursuant to 19 CFR 210.16, because they did not respond to the complaint and notice of investigation and Order No. 16. No party petitioned for review.

The Commission has determined not to review the subject ID. Accordingly, the Ourway respondents, InkSell.com, Bluedog, Ink4Work.com, Ink Technologies, SuperMediaStore.com, CLT Computers, Imaging Supplies, Online Tech Stores, ProPrint, and Zeetoner have been found in default.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, and in Part 210 of the Commission's Rules of Practice and Procedure, 19 CFR part 210.
