**NOTICE OF COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL
DETERMINATION GRANTING A JOINT MOTION TO TERMINATE THE
INVESTIGATION AS TO CERTAIN PARTIES**

SUMMARY: Notice is hereby given that the U.S. International Trade Commission (the “Commission”) has determined not to review a July 2, 2018, initial determination (the “ID”) (Order No. 6) terminating this investigation as to Barco NV and Barco Inc.

SUPPLEMENTARY INFORMATION: On May 31, 2018, the Commission instituted this investigation based on a complaint (and an amendment and supplement thereto) filed on behalf of Ultravision Technologies, LLC of Dallas, Texas (“Ultravision”). 83 FR 25044 (May 31, 2018). The amended and supplemented complaint alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain modular LED display panels and components thereof by reason of infringement of claims 1, 3-10, 12-14, 16-19, 21-23, and 25-27 of U.S. Patent No. 9,349,306 and claims 1-6, 9-14, 16, and 22-28 of U.S. Patent No. 9,916,782. The Commission’s Notice of Investigation named forty parties as respondents, including Barco NV of Kortrijk, Belgium and Barco Inc. of Duluth, Georgia

(collectively, the “Barco Respondents”). *Id.* The Office of Unfair Import Investigations was also named as a party in this investigation. *Id.*

On July 2, 2018, the presiding administrative law judge (“ALJ”) issued Order No. 6, the subject ID, which grants a joint motion filed by Ultravision and the Barco Respondents requesting that the investigation be terminated as to the Barco respondents “for good cause on the basis of their Confidential Standstill Agreement.” ID at 1, 3. OUII filed a response in support of the motion. *Id.* at 2. The ID finds that the private parties’ motion complies with the Commission’s rules in that the parties have provided a confidential and a public version of the their agreement and have stated that “[t]here are no other agreements, written or oral, express or implied, between the parties concerning the subject matter of this investigation.” *Id.* at 3. The ID additionally finds that “there are no extraordinary circumstances that warrant denying the motion.” *Id.* The ID further finds that terminating this investigation as to the Barco Respondents would not be contrary to the public interest. *Id.* No party filed a petition seeking review of the subject ID. The Commission has determined not to review the ID.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in part 210 of the Commission’s Rules of Practice and Procedure (19 CFR part 210).
