**NOTICE OF COMMISSION DECISION NOT TO REVIEW AN INITIAL  
DETERMINATION GRANTING A MOTION FOR PARTIAL TERMINATION  
OF THE INVESTIGATION AS TO CERTAIN RESPONDENTS**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 30) of the presiding administrative law judge (“ALJ”) granting a motion to partially terminate the investigation as to respondents Zhangjiagang Elegant Plastics Co. Ltd. of Zhangjiagang, China; Zhangjiagang Yihua Plastics Co., Ltd. of Zhangjiagang, China; and Zhejiang Kimay Building Material Technology Co., Ltd. of Zhejiang, China (collectively, “Name Change Respondents”) based on the withdrawal of the allegations as to those respondents.

**SUPPLEMENTARY INFORMATION:** On May 16, 2019, the Commission instituted this investigation under section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337 (“section 337”), based on a complaint filed by Mohawk Industries, Inc. of Calhoun, Georgia; Flooring Industries Ltd. Sarl of Bertrange, Luxembourg; and IVC US Inc. of Dalton, Georgia (collectively, “Complainants”). *See* 84 FR 22161 (May 16, 2019). The complaint, as supplemented, alleges a violation of section 337 based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain luxury vinyl tile and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 9,200,460; 10,208,490; and 10,233,655. *See id.* The notice of investigation names

numerous respondents, including Name Change Respondents. *See id.* The Office of Unfair Import Investigations (“OUII”) is also a party to the investigation. *See id.*

On October 4, 2019, Complainants filed a motion to partially terminate the investigation as to Name Change Respondents. On October 16, 2019, OUII filed a response in support of the motion.

On October 25, 2019, the ALJ issued the subject ID (Order No. 30) granting the motion. The ID finds good cause to partially terminate the investigation as to Name Change Respondents because they no longer exist as legal entities. *See ID at 4.* In addition, in accordance with Commission Rule 210.21(a)(1), 19 CFR 210.21(a)(1), the ID notes that “[other than the identified agreements,] [t]here are no other agreements, written or oral, express or implied, between Complainants and the Name Change Respondents concerning the subject matter of this Investigation.” *See id.* Furthermore, the ID finds no evidence that terminating the investigation as to Name Change Respondents would be contrary to the public interest. *See id.*

No petition for review of the subject ID was filed. The Commission has determined not to review the subject ID.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in part 210 of the Commission’s Rules of Practice and Procedure (19 CFR part 210).
