RESPONDENT EASTMAN KODAK COMPANY BASED ON A CONSENT ORDER;  
ISSUANCE OF CONSENT ORDER**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination ("ID") (Order No. 26) of the presiding administrative law judge ("ALJ") terminating the above-captioned investigation as to respondent Eastman Kodak Company ("Kodak") of Rochester, New York based on a consent order.


**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on September 27, 2011, based on a complaint filed by Technical Properties Limited, LLC of Cupertino, California. 76 *Fed. Reg.* 59737-38. The complaint alleges a violation of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain digital photo frames and image display devices and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 6,976,623; 7,162,549; 7,295,443; and 7,522,424. The complaint further alleges the existence of a domestic industry. The Commission's notice of investigation named twenty respondents including Kodak.

On March 22, 2012, Kodak moved to terminate the investigation as to itself based on a consent order. No responses were filed.

The ALJ issued the subject ID on March 22, 2012, granting Kodak's motion for termination. He found that the motion for termination by consent order satisfied Commission rule 210.21(c)(3). He further found, pursuant to Commission rule 210.50(b)(2), that termination of this investigation as to Kodak by consent order is in the public interest. No party petitioned for review of the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, and in sections 210.21 and 210.42(h) of the Commission's Rules of Practice and Procedure, 19 C.F.R. §§ 210.21, 210.42(h).
