INITIAL DETERMINATION TERMINATING GHP GROUP, INC. BASED ON A  
SETTLEMENT AGREEMENT, PATENT LICENSE AGREEMENT AND ISSUANCE  
OF A CONSENT ORDER; ISSUANCE OF A CONSENT ORDER**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 53) terminating named respondent GHP Group, Inc. ("GHP").

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on September 26, 2013, based on a complaint filed on behalf of A&J Manufacturing, LLC of St. Simons, Georgia and A&J Manufacturing, Inc. of Green Cove Springs, Florida (collectively "Complainants"). 78 Fed. Reg. 59373 (Sept. 26, 2013). The complaint alleged violations of Section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the sale for importation, importation, or sale within the United States after importation of certain multiple mode outdoor grills and parts thereof by reason of infringement of certain claims of U.S. Patent No. 8,381,712,

U.S. Patent No. D660,646, and U.S. Patent No. D662,773 patent. The Commission's notice of investigation, as amended, named several respondents, including GHP.

On July 11, 2014, Complainants and GHP filed a joint motion to terminate the investigation based upon a settlement agreement, a license agreement, a consent order stipulation and a proposed consent order. The moving parties represented that there are no other agreements, written or oral, other than the Consent Order Stipulation, Settlement Agreement and Mutual Release, and Patent License Agreement. The moving parties provided redacted versions of the Settlement Agreement and Mutual Release, and Patent License Agreement. The redacted versions, which did not contain essential financial terms, were for service on the remaining non-moving respondents. The Office of Unfair Import Investigations filed a response in support of the motion. The remaining non-moving respondents filed a response to the motion opposing the service of redacted documents on them.

On July 24, 2014, the ALJ granted the motion for termination of GHP. The ALJ found that the Consent Order and Consent Order Stipulation complied with the Commission's rules. The ALJ also found that there was no evidence that terminating the investigation as to GHP would be contrary to the public interest. He also found good cause to redact the essential financial terms from the version of the motion that was served on the non-moving respondents. No petitions for review were filed.

The Commission has determined not to review the subject ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 C.F.R. Part 210).
