**NOTICE OF COMMISSION DECISION NOT TO REVIEW AN  
INITIAL DETERMINATION EXTENDING THE TARGET DATE  
BY TEN DAYS**

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 37) extending the target date for completion of the above-captioned investigation from March 20, 2017, to March 30, 2017.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on November 20, 2015, based on a complaint filed by Diebold Incorporated and Diebold Self-Service Systems (collectively, "Diebold"). 80 *Fed. Reg.* 72735-36 (Nov. 20, 2015). The complaint alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. § 1337, in the importation into the United States, the sale for importation, and the sale within the United States after importation of certain automatic teller machines, ATM modules, components thereof, and products containing the same by reason of infringement of certain claims of six patents. *Id.* The notice of investigation named as

respondents Nautilus Hyosung Inc. of Seoul, Republic of Korea; Nautilus Hyosung America Inc. of Irving, Texas; and HS Global, Inc. of Brea, California (collectively, “Nautilus”). *Id.* at 72736.

On December 7, 2015, the ALJ issued Order No. 4, which set the target date for completion of the investigation at sixteen months, *i.e.*, March 20, 2017. Order No. 4 at 2. Pursuant to that order, the deadline for issuance of the final initial determination (“final ID”) was November 21, 2016. *Id.* On November 18, 2016, the ALJ issued the subject ID (Order No. 37), which extended the target date by ten days from March 20, 2017, to March 30, 2017. Order No. 37 at 2. Consequently, the final ID will be due on November 30, 2016. *Id.* The subject ID explained that good cause exists for the extension. *Id.* at 1. In particular, additional time is needed to complete the final ID because of the complexity of the investigation and significant motions practice in another investigation. *Id.*

No petitions for review were filed. The Commission has determined not to review the subject ID.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. § 1337), and in Part 210 of the Commission’s Rules of Practice and Procedure (19 C.F.R. Part 210).
