7. DEMONSTRATION OF CONTRACTOR OR BRAND UNIQUE QUALIFICATIONS
The Commission has been a subscriber to World Trade Online since its first year - 1982.
Over the years the service has evolved from a printed weekly newsletter to an Online service with daily updates. These daily updates generally provide the first and quickest access to public trade negotiation documents promulgated by such organizations as the WTO. The updates also generally provide the earliest and quickest access to local international trade issues.
World Trade Online has a 34 year historical database that allows the user to search for and retrieve from one source primary and other documents related to various trade negotiations. Working in this one database the user can easily put together such things as a linear time line of a negotiation such as the Softwood Lumber Agreement.
While the service does provide daily updates - one of its most popular resources is its Friday newsletter Inside US Trade. The weekly newsletter provides a quick synopsis of what has happened in the trade field during the past week.
World Trade Online also offers access trade information from China. Again the service generally offers the first and quickest access to what is happening in China.
8. DESCRIPTION OF EFFORTS MADE TO ENSURE OFFERS WERE SOLICITED FROM AS MANY POTENTIAL SOURCES AS IS PRACTICABLE
Law Library staff has reviewed the offerings of comparable vendors and found no other sources for the services. One important thing other vendors do not have is the in-depth current and historical coverage of China - which helps with the agency's China studies.
