## CHANGE RECORD TO SUPPLEMENT 1 OF THE HTS (2012)

This change record reflects legal and statistical changes to the HTS since the issuance of the Basic Edition, effective February 3, 2012, and it records the changes set forth in the noncumulative online Revisions to the Basic Edition. The table below reflects the implementation of the U.S.-Korea Free Trade Agreement and the U.S.-Colombia Trade Promotion Agreement, but it does not record the insertion of the pertinent Special rates of duty pursuant to those agreements in each tariff rate line. It also reflects the other instruments noted in the Preface. Included are substantive corrections to individual tariff pages made since February 3 that may be of help to users.
