**SUPPLEMENTARY INFORMATION**: On June 11, 2018, the Commission instituted this investigation based on a complaint (and a supplement thereto) filed on behalf of The Chamberlain Group, Inc. of San Jose, CA. 83 FR 27020 (June 11, 2018). The complaint and supplement alleged violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain movable barrier operator systems and components thereof by reason of infringement of claims 7, 11, and 16-18 of U.S. Patent No. 8,587,404; claims 1, 2, 9, 13, 14, and 18-22 of U.S. Patent No. 7,755,223; and claims 1, 9-15, 22, and 27 of U.S. Patent No. 6,741,052. *Id.* The Commission's Notice of Investigation named as respondents Nortek Security & Control, LLC of Carlsbad, CA; Nortek, Inc. of Providence, RI;

and GTO Access Systems, LLC of Tallahassee, FL. *Id.* The Office of Unfair Import Investigations was not named as a party in this investigation. *Id.* 

On June 20, 2018, the presiding administrative law judge ("ALJ") issued Order No. 2, the subject ID, which set the target date for the completion of this investigation pursuant to Commission Rule 210.51(a). The ALJ determined that a target date of seventeen months is appropriate, and therefore set the target date for November 12, 2019. No party filed a petition seeking review of the subject ID. The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in part 210 of the Commission's Rules of Practice and Procedure (19 CFR part 210).
