**NOTICE OF COMMISSION DECISION NOT TO REVIEW AN
INITIAL DETERMINATION TERMINATING THE INVESTIGATION AS TO
CERTAIN PATENTS AND CLAIMS**

AGENCY: U.S. International Trade Commission.

ACTION: Notice.

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 18) of the presiding administrative law judge (“ALJ”), terminating the investigation as to: (1) all asserted claims of U.S. Patent Nos. 8,001,564 (“the ’564 patent”); 7,301,900 (“the ’900 patent”); and 7,386,871 (“the ’871 patent”); (2) claims 1-4, 6-7, 10-11, 15-22, and 24 of U.S. Patent No. 7,779,445 (“the ’445 patent”); (3) claims 1-3, 6, 11, 14-18, 20, 23-24, 26, 29, 31, and 34-36 of U.S. Patent No. 8,156,528 (“the ’528 patent”); and (4) claims 1-13, 15-28, 30-50, 52-59, and 61-62 of U.S. Patent No. 7,200,855 (“the ’855 patent”) (collectively, the “Withdrawn Patents and Claims”).

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on May 29, 2019, based on a complaint filed by Rovi Corporation and Rovi Guides, Inc., both of San Jose, California. 84 *Fed. Reg.* 24814-15 (May 29, 2019). The complaint alleges violations

of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain digital video receivers, broadband gateways, and related hardware and software components by reason of infringement of certain claims of the '564, '445, '871, '528, '900, and '855 patents. The complaint further alleges the existence of a domestic industry. The Commission's notice of investigation named as respondents Comcast Corporation, Comcast Cable Communications, LLC, Comcast Cable Communications Management, LLC, and Comcast Holdings Corporation, all of Philadelphia, Pennsylvania. The Office of Unfair Import Investigations is participating in the investigation.

On September 12, 2019, Rovi filed an unopposed motion to terminate the investigation as to the Withdrawn Patents and Claims.

On September 30, 2019, the ALJ issued the subject ID (Order No. 18) granting Rovi's motion for partial termination as to the Withdrawn Patents and Claims. The ID finds that the motion for termination satisfied Commission Rule 210.21(a)(1), 19 C.F.R. 210.21(a) and that no extraordinary circumstances exist that would prevent the requested partial termination. No petitions for review were filed.

The Commission has determined not to review the ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, and in part 210 of the Commission's Rules of Practice and Procedure, 19 CFR part 210.
