NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL DETERMINATION FINDING THE DALIAN RESPONDENTS IN DEFAULT

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination ("ID") (Order No. 7) of the presiding Administrative Law Judge ("ALJ") finding Dalian Takebishi Packing Industry Co., Ltd. of XiGang District of Dalian, China and Dalian Altma Industry Co., Ltd. of Economic and Technological Development Zone of Dalian, Liaoning, China (collectively, "Dalian Respondents") in default.

SUPPLEMENTARY INFORMATION: On August 21, 2019, the Commission instituted this investigation under section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, based on a complaint filed by Reynolds Presto Products Inc. of Lake Forest, Illinois. 84 FR 43616-17 (Aug. 21, 2019). The notice of investigation ("NOI"), as supplemented, alleges a violation of section 337 by reason of infringement of certain claims of U.S. Patent Nos. 9,505,531; 9,554,628; and 10,273,058. The NOI names as respondents Dalian Respondents; Japan Takebishi Co., Ltd. of Tokyo, Japan; Takebishi Co., Ltd. of Shiga, Japan; Shanghai Takebishi Packing Material Co., Ltd. of Shanghai, China; and Qingdao Takebishi Packing Industry Co., Ltd. of Jimo City, Qingdao, China. *Id.* at 43616-17. The Office of Unfair Import Investigations is also named as a party in this investigation. *Id.*

The complaint and NOI were served on the Dalian Respondents on August 16, 2019. See NOI (Public Certificate of Service). No responses were filed. On October 8, 2019, the ALJ issued an order pursuant to Commission Rule 210.16, 19 CFR 210.16, directing the Dalian Respondents to show cause why they should not be found in default for failing to respond to the complaint and NOI after the service was effected. Order No. 6. That order gave the Dalian Respondents until October 25, 2019, to make such a showing. *Id.* at 2-3. The Dalian Respondents failed to respond to Order No. 6.

On October 30, 2019, the ALJ issued the subject ID. The ID finds that the Dalian Respondents have not responded to the order to show cause, and, therefore, "they necessarily have failed to make the requisite showing of good cause to avoid default under the applicable rules." ID at 1. Accordingly, the ID determined that the Dalian Respondents "are in default pursuant to 19 CFR § 210.16. They therefore have no right to appear, to be served with documents, or to contest the allegations in the investigation." *Id.* at 2 (citing 19 CFR 210.16(b)(4)). No party petitioned for review of the ID.

The Commission has determined not to review the subject ID.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, and in Part 210 of the Commission's Rules of Practice and Procedure, 19 CFR part 210.
