**NOTICE OF COMMISSION DECISION NOT TO REVIEW AN  
INITIAL DETERMINATION TERMINATING THE INVESTIGATION AS TO  
CERTAIN PATENT CLAIMS**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission has determined not to review an initial determination (“ID”) (Order No. 13) of the presiding administrative law judge (“ALJ”), terminating the investigation as to: (1) claims 7 and 16 of U.S. Patent No. 9,576,169 (“the ’169 patent”); (2) claim 14 of U.S. Patent No. 7,770,799 (“the ’799 patent”); (3) claims 17 and 26 of U.S. Patent No. 7,568,628 (“the ’628 patent”); and (4) all asserted claims of U.S. Patent No. 8,794,520 (“the ’520 patent”) (all collectively, the “Withdrawn Patent and Claims”).

**SUPPLEMENTARY INFORMATION:** On November 4, 2021, the Commission instituted this investigation based on a complaint filed on behalf of Honeywell International Inc., Hand Held Products, Inc., and Metrologic Instruments, Inc. (collectively, “Complainants”), all of Charlotte, North Carolina. 86 FR 60915 (Nov. 4, 2021). The complaint alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain bar code scanners, mobile computers with bar code scanning capabilities, scan engines, and components thereof that infringe one or more claims of U.S. Patent No. 10,721,429 and the ’169, ’799, ’628, and ’520 patents. *Id.* The complaint also alleges that a

domestic industry exists or is in the process of being established. *Id.* The Commission's notice of investigation named Zebra Technologies Corporation of Lincolnshire, Illinois and Symbol Technologies, Inc. of Holtsville, New York as respondents: *Id.* The Office of Unfair Import Investigations is participating in this investigation. *Id.*

On April 5, 2022, Complainants filed an unopposed motion to terminate the investigation as to the Withdrawn Patent and Claims based on the withdrawal of the allegations in the complaint.

On April 7, 2022, the ALJ issued the subject ID (Order No. 13) granting Complainants' motion for partial termination as to the Withdrawn Patent and Claims. The ID finds that the motion for termination satisfies Commission Rule 210.21(a)(1), 19 CFR 210.21(a)(1), and that no extraordinary circumstances exist that would prevent the requested partial termination. No petitions for review were filed.

The Commission has determined not to review the subject ID. Claims 7 and 16 of the '169 patent, claim 14 of the '799 patent, claims 17 and 26 of the '628 patent, and all asserted claims of the '520 patent are terminated from this investigation.

The Commission vote for this determination took place on April 25, 2022.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in part 210 of the Commission's Rules of Practice and Procedure (19 CFR part 210).
