NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL DETERMINATION GRANTING MIANYANG BOE OPTOELECTRONICS TECHNOLOGY CO., LTD.'S MOTION TO INTERVENE AS A RESPONDENT

SUMMARY: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 7) granting Mianyang BOE Optoelectronics Technology Co., Ltd.'s ("Mianyang BOE") motion to intervene as a respondent.

SUPPLEMENTARY INFORMATION: On February 3, 2023, the Commission instituted this investigation based on a complaint filed by Samsung Display Co., Ltd. of the Republic of Korea ("Complainant Samsung"). 88 FR 7463-64 (Feb. 3, 2023). The complaint alleges violations of section 337 based upon the importation into the United States, the sale for importation, or sale within the United States after importation of certain active matrix organic light-emitting diode display panels and modules for mobile devices, and components thereof by reason of the infringement of certain claims of U.S. Patent No. 9,818,803; U.S. Patent No. 10,854,683; U.S. Patent No. 7,414,599; and U.S. Patent No. 9,330,593. *Id.* The Commission's notice of investigation named the following respondents: Apt-Ability LLC d/b/a MobileSentrix of Chantilly, VA; Mobile Defenders, LLC of Caledonia, MI; DFW Imports LLC d/b/a DFW Cellphone and Parts of Dallas, TX; Electronics Universe, Inc. d/b/a Fixez.com of Las Vegas, NV; Electronics Universe, Inc. d/b/a Repairs Universe, Inc. of Las Vegas, NV; eTech Parts Plus

LLC of Southlake, TX; Gadgetfix Corp. of Irvine, CA; Injured Gadgets, LLC of Norcross, GA; LCTech International Inc. d/b/a SEGMobile.com of City of Industry, CA; Parts4Cells Inc. of Houston, TX; Parts4LCD of Wayne, NJ; Phone LCD Parts LLC of Wayne, NJ; Wholesale Gadget Parts, Inc. of Bixby, OK; Group Vertical, LLC of Grand Rapids, MI; Sourcely Plus, LLC of Tempe, AZ; Captain Mobile Parts, Inc. of Dallas, TX; and Mengtor Inc. of El Monte, CA. *Id.* The Office of Unfair Import Investigations ("OUII") was also named as a party in this investigation. *Id.*

On February 22, 2023, Mianyang BOE moved pursuant to 19 CFR 210.19 to intervene as a respondent in this investigation. ID at 1. OUII supported the motion. *Id.* Among the respondents who have appeared in this investigation, none opposed the motion. *Id.* Complainant Samsung did not oppose the motion based on certain representations made by Mianyang BOE. *Id.* at 1-2.

On March 15, 2023, the presiding ALJ issued the subject ID, granting Mianyang BOE's unopposed motion to intervene. The subject ID finds that the motion was "timely filed" and that "no party claims any undue prejudice from Mianyang BOE's intervention." ID at 4. The subject ID also finds that "Mianyang BOE's participation will facilitate discovery and aid the Commission in resolving the parties' dispute." *Id.* No petitions for review of the subject ID were filed.

The Commission has determined not to review the subject ID. Pursuant to Commission Rule 210.19, Mianyang BOE is accorded respondent status in this Investigation.

The Commission vote for this determination took place on March 21, 2023.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
