**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL  
DETERMINATION TERMINATING THE INVESTIGATION AS TO CERTAIN  
PATENT CLAIMS BASED ON PARTIAL WITHDRAWAL OF THE COMPLAINT**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission (“Commission”) has determined not to review an initial determination (“ID”) (Order No. 52) of the presiding administrative law judge (“ALJ”) granting complainants’ unopposed motion to terminate the above-captioned investigation as to claims 3, 6, 9, 12, 15, 17, 20, 23, 24, 30, 32-34, 36, 41, 44, 49, 51, 52, 54, 59, 60, 62, 64, and 65 of U.S. Patent No. 7,532,808 (“the ’808 patent”) and claims 10, 12, and 16-22 of U.S. Patent No. 8,204,134 (“the ’134 patent”) based on partial withdrawal of the complaint.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on December 6, 2023, based on a complaint filed by Nokia Technologies Oy and Nokia Corporation, both of Espoo, Finland (collectively, “Complainants”). 88 FR 84832-33 (Dec. 6, 2023). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, in the importation into the United States, the sale for importation, or the sale within the United States after importation of certain video capable

electronic devices, including computers, streaming devices, televisions, cameras, and components and modules thereof by reason of infringement of claims 1-3, 6, 7, 9-12, 15-17, 20-25, 28-30, 32-34, 36, 39-41, 43, 44, 47-49, 51-54, 58-60, and 62-65 of the '808 patent and claims 1-22 of the '134 patent. *Id.* at 84832. The complaint further alleges that a domestic industry exists. *Id.* The Commission's notice of investigation named as respondents HP, Inc. of Palo Alto, California; and Amazon.com, Inc. and Amazon.com Services LLC, both of Seattle, Washington (collectively, "Respondents"). *Id.* The Office of Unfair Import Investigations ("OUII") is participating in the investigation. *Id.*

On July 3, 2024, the Commission determined not to review an initial determination (Order No. 44) granting Complainants' unopposed motion to terminate the investigation as to claims 2, 11, 25, 28, 39, 43, 47, 53, 58, and 63 of the '808 patent and claims 1-8 of the '134 patent. *See* Order No. 44 (June 11, 2024), *unreviewed by* Comm'n Notice (July 3, 2024).

On July 1, 2024, Complainants filed a motion to terminate the investigation as to claims 3, 6, 9, 12, 15, 17, 20, 23, 24, 30, 32-34, 36, 41, 44, 49, 51, 52, 54, 59, 60, 62, 64, and 65 of the '808 patent and claims 10, 12, and 16-22 of the '134 patent. The motion states that Respondents did not oppose the motion, and OUII would take a position after reviewing the papers. OUII filed a response supporting the motion. No other responses were filed.

On July 10, 2024, the ALJ issued the subject ID (Order No. 52), granting Complainants' unopposed motion to terminate the investigation as to the specified claims of the '808 and '134 patents. *ID* at 1-2. The subject ID finds that Complainants meet the requirements of Commission Rule 210.21(a) (19 CFR 210.21(a)), and that there are no extraordinary circumstances that would prevent the requested partial termination of the investigation. *Id.* at 2. No petitions for review of the ID were filed.

The Commission has determined not to review the subject ID. The following claims are hereby terminated from the investigation: claims 3, 6, 9, 12, 15, 17, 20, 23, 24, 30, 32-34, 36, 41, 44, 49, 51, 52, 54, 59, 60, 62, 64, and 65 of the '808 patent and claims 10, 12, and 16-22 of the '134 patent.

The Commission vote for this determination took place on August 5, 2024.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission's Rules of Practice and Procedure (19 CFR Part 210).
