**NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW**  
**AN INITIAL DETERMINATION FINDING A RESPONDENT IN DEFAULT**

**AGENCY:** U.S. International Trade Commission.

**ACTION:** Notice.

**SUMMARY:** Notice is hereby given that the U.S. International Trade Commission (“Commission”) has determined not to review an initial determination (“ID”) (Order No. 7) issued by the presiding administrative law judge (“ALJ”) finding respondent Medical Purchasing Resource, LLC in default.

**SUPPLEMENTARY INFORMATION:** The Commission instituted this investigation on September 13, 2024, based on a complaint, as supplemented, filed by HydraFacial LLC f/k/a Edge Systems LLC of Long Beach, California (“HydraFacial”). 89 FR 74995-96 (September 13, 2024). The complaint, as supplemented, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337 (“section 337”), based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain hydrodermabrasion systems and components thereof by reason of the infringement of certain claims of U.S. Patent No. 11,446,477 (“the ’477 patent”). *Id.* The complaint also asserts that a domestic industry exists.

The Commission’s notice of investigation names as respondents: Luvo Medical Technologies Inc. of Ontario, Canada; Clarion Medical Technologies, Inc. of Ontario, Canada; Healthcare Markets, Inc. d/b/a Powered by MRP of Park City, Utah; Medical Purchasing Resource, LLC of Little Elm, Texas; Bio-Infusions USA Inc. of Seminole, Florida; MIRAmtech UG of Neulingen, Germany; eMIRAmtech USA, LLC of Irvine, California; and MIRAmtech SP. Z.O.O. of Warsaw, Poland. *Id.* The Office of Unfair Import Investigations is not participating in this investigation. *Id.*

On October 4, 2024, respondent Medical Purchasing Resource, LLC filed a notice of intent to default in the investigation, stating that it has “not filed a response to the Second Amended Complaint and Notice of Investigation and does not intend to do” and requesting the ALJ to issue an initial determination pursuant to Commission Rule 210.16(b)(3), 19 CFR 210.16(b)(3).

On December 9, 2024, the ALJ issued the subject ID (Order No. 7) pursuant to Commission Rule 210.16(b)(3), 19 CFR 210.16(b)(3), finding Medical Purchasing Resource, LLC in default. The ID also finds that Medical Purchasing Resource, LLC has “waived its rights to appear, to be served with documents, and to contest the allegations in the investigation.” ID at 1; *see* 19 CFR 210.16(b)(4).

No party filed a petition for review of the subject ID.

The Commission has determined not to review the subject ID (Order No. 7). Medical Purchasing Resource, LLC is hereby found in default.

The Commission vote for this determination took place on January 2, 2025.

The authority for the Commission’s determination is contained in section 337 of the Tariff Act of 1930, as amended (19 U.S.C. 1337), and in Part 210 of the Commission’s Rules of Practice and Procedure (19 CFR Part 210).
