3 CHAIRMAN JOHANSON: Good morning. This meeting of
4 the U.S. International Trade Commission will now come to
5 order. Welcome to Commissioners Broadbent and Kearns who
6 are participating by telephone.

11 or outstanding action jackets to consider.

13 of Investigation Numbers 701-TA-623 and 731-TA-1449,
14 concerning imports of Vertical Metal File Cabinets from
15 China.
