

Changes to the HTS for February 8, 2020

The following changes to chapter 87 of the Harmonized Tariff Schedule will take effect on February 8, 2020. The 484(f) Committee was asked to make these changes to the statistical reporting numbers of HTS 8708.10.30 and 8708.29.21 in order to assist U.S. Customs and Border Protection with the administration of the requirements announced in Presidential Proclamation 9980 of January 24, 2020, "Adjusting Imports of Derivative Aluminum Articles and Derivative Steel Articles Into the United States" (85 F.R. 5281) (<https://www.federalregister.gov/documents/2020/01/29/2020-01806/adjusting-imports-of-derivative-aluminum-articles-and-derivative-steel-articles-into-the-united>). There are other changes to the HTS taking effect on February 8 as a result of this proclamation. Those changes will be referenced in the preface to HTS 2020, Revision 2. They can also be found in Annex I and Annex II of the proclamation.
