## A BILL

To reduce temporarily the duty on mixtures of 6-amino-5-chloro-2-cyclopropyl-pyrimidine-4-carboxylic acid and inert ingredients.

- 3 SECTION 1. MIXTURES OF 6-AMINO-5-CHLORO-2-
- 4 CYCLOPROPYL-PYRIMIDINE-4-CARBOXYLIC
- 5 ACID AND INERT INGREDIENTS.
- 6 (a) In General.—Subchapter II of chapter 99 of
- 7 the Harmonized Tariff Schedule of the United States is
- 8 amended by inserting in numerical sequence the following
- 9 new heading:
