10 (a) IN GENERAL.—Heading 9902.40.02 of the Har-
 11 monized Tariff Schedule of the United States (relating to
 12 aqueous emulsion of a modified aliphatic amine mixture
 13 of: decanedioic acid, compounds with 1,3-
 14 benzenedimethanamine- bisphenol A-bisphenol A
 15 diglycidyl etherdiethylenetriamine glycidyl phenyl ether re-
 16 action product epichlorohydrin formaldehyde- propylene
 17 oxidetriethylenetetramine polymer) is amended by striking
 18 the date in the effective period column and inserting “12/
 19 31/2015”.

20 (b) EFFECTIVE DATE.—The amendment made by
 21 subsection (a) applies with respect to goods entered, or
 22 withdrawn from warehouse for consumption, on or after
 23 the 15th day after the date of enactment of this Act.
