II. Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Covers with outer surface of plastics, each such cover designed to convert to a stand and incorporate a frame to hold portable electronic devices of a kind classified in heading 8470, 8471, 8543 or 8517 (provided for in subheading 3926.10.00)

(If enacted, the tariff relief provided for in this bill would be available to any entity that imports the product that is covered by the bill.)

III. Other product information, including uses/applications and source(s) of imports

The subject products are soft, plastic covers designed to hold a large variety of portable electronic devices such as electronic readers and tablets when they are set on a table or similar surface. These products are imported mainly from China, Taiwan, and Korea. Several binding rulings from U.S. Customs and Border Protection cover these products: N056187, April 23, 2009; N150305, March 25, 2011; and N185835, October 21, 2011.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CERTAIN PLASTIC DEVICE COVERS AND**
4 **STANDS.**

5 (a) IN GENERAL.—Subchapter II of chapter 99 of
6 the Harmonized Tariff Schedule of the United States is
7 amended by inserting in numerical sequence the following
8 new heading:

1 (b) **EFFECTIVE DATE.**—The amendment made by
