A BILL

To suspend temporarily the duty on 1,3,5-triazine-2,4,6-triamine, polymer with formaldehyde.

3 **SECTION 1. 1,3,5-TRIAZINE-2,4,6-TRIAMINE, POLYMER WITH**
4 **FORMALDEHYDE.**

5 (a) IN GENERAL.—Subchapter II of chapter 99 of
6 the Harmonized Tariff Schedule of the United States is
7 amended by inserting in numerical sequence the following
8 new heading:
