4 meeting of the U.S. International Trade Commission will now

11 CHAIRMAN SCHMIDTLEIN: I understand that there
12 are no amendments for future meetings or outstanding

25 with respect to Brazil. And I vote in the affirmative with

1 respect to all other subject countries.
