**Note:** Specific to question V-8 (bid data) from the U.S. purchasers' questionnaire in this case, the D-GRIDs number represents the first cell (which is not numeric data) in the bid table, the D-GRIDs tool will only pull and push the numeric data from the 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> columns of the grid. Text, drop down selection, and checkbox data will not be extracted nor overwritten using the D-GRIDs functionality.
